IN THE GREATER LOWELL AREA WE CONTINUE TO BUILD THE CAPACITY OF THE ORGANIZATION EITHER THROUGH BUILDING NEW HOMES OR RENOVATING OWNER OCCUPIED HOMES, STARTING WITH VETERANS AND MILITARY FAMILIES AND THEN BRANCHING OUT TO ALL POTENTIAL FAMILIES. THE RESTORE ACCEPTS DROP OFFS OR WILL SCHEDULE FREE PICK UPS FOR NEW AND GENTLY USED HOME IMPROVEMENT MATERIALS, HOME GOODS, FURNITURE, LIGHTING, FLOORING AND APPLIANCES. THESE ITEMS ARE THEN SOLD AT 50-70% OFF RETAIL PRICES TO PEOPLE OF ALL INCOME LEVELS, THEREFORE GENERATING FUNDS TO BUILD MORE AFFORDABLE HOMES IN THE GREATER LOWELL AREA.
